# The LITTLE Automobile




William Henry Little was born February 4, 1876 in Westboro Massachusetts to Michael and Ellen Magner Little. His early education was in public school, where he showed great interest in athletics. At age 15, he acquired work at a local bicycle shop. His love of mechanized transportation led him to jobs with the Bridgeport Locomobile Works, the Edison Company, Buick Automobiles and General Motors. In 1911 he was Vice President of Scripps-Booth Automobile Company, and organized the Sterling Motor Company of Detroit.

On October 30, 1911, Little, along with Charles M. Begole and William S. Ballinger, incorporated The Little Motor Car Company of Flint, Michigan. The purpose of the company, according to its Annual Report of December 31, 1912, was to manufacture "motor vehicles and other vehicles, and the various parts thereof and accessories thereto." The car was advertised for \$795.00, fully equipped. "Fully equipped" meant, in addition to the engine, chassis, brakes, and wheels, the vehicle was delivered with two headlights, two side lights, a tail lamp, horn, windshield, top and side curtains, jack, tire repair kit, tire pump, and tools. Not bad for an industry that, prior to 1911, had considered windshields an aftermarket extra! In 1913 the company began production of the Little Six, a six-cylinder vehicle advertised as "just as attractive - coming or going."


Unlike most automobile manufacturers in existence in the early part of this century, The Little MotorCar Company must be considered a success. Between October 1911 and June 1913, the company produced about 3000 "Little Fours", the "classiest of all little Roadsters", and over 400 "Little Sixes", the "Product of Experience". Most of the 1500 car companies in existence at the time never got their products off the drawing board or past the prototype stage. On June 11, 1913, The Little Motor Car Company was purchased by Chevrolet Motor Company, and was absorbed into General Motors.

William Henry Little died of heart failure in 1922, and is buried in the Roselawn Cemetery in Detroit, Michigan. He is remembered in the Encyclopedia of Biography as "a man of strong character and great business ability, one who accomplished much in his short life of forty-six years."

A roster of Little Motor Cars compiled on September 20,1994, showed that there are 32 of the vehicles still in existence, in states of repair ranging from "Spare Engine Only" to "Completely Restored".
